Means the level which automatically activates the standing order for the replenishment of the Subscription Account through Credit Card. The Subscriber may readjust the level at a higher amount.

Means the warning optical and/or acoustic signal which warns the Subscriber that the balance of his/her Subscription Account is low and reaches the Bad Account Level. The Subscriber may readjust the level at a higher amount.

Means the level of the Subscription Account over which no Subscription Entry is allowed by the electronic toll system. The last Subscription Entry can only be realized if the Subscription Account has a cash balance higher than the Bad Account Level. Otherwise, the entry can only be realized with payment of the full toll rate without discount through a manual lane.
